

General contract declaration of applicant and driver:

Applicants/drivers assure that the information provided in the entry is correct and complete, that the driver has a valid driving licence to drive the vehicle to be used and that he is fully up to the requirements of the racing competitions. They further assure that the vehicle complies in all respects with the technical provisions of the ASS approved regulations for the Int. British HTGT Competition and that they will only use it in perfect condition at the events. With their signature, they further declare that:

- they have taken note of the FIA's International Automobile Racing Act, the ASS Circuit Racing Regulations, the General Championship Regulations of the ASS, the Special Provisions of the Int. British HTGT Competition, the Legal and Procedural Rules of the ASS and the other FIA and ASS regulations,
- these rules and regulations become part of the Nomination Agreement with their consent,
- you will acknowledge and comply with them as binding on you,
- the sports commissioners of the events and the ASS jurisdiction are entitled, within the scope of their jurisdiction, to impose contractual penalties in the event of violations.

Protest and power of appeal:

The Applicant hereby authorises the Driver to exercise the right of protest and appeal on behalf of the Applicant. The driver is authorised to make and accept all declarations in the protest and appeal proceedings for and against the applicant. This also applies to communications from the organizer which, unless otherwise determined by the applicant/driver, are addressed to the driver.

By submitting the entry, the Contestant and the Driver declare the waiver of claims of any kind for damages arising in connection with the Event against:

- the FIA, ASS, the member organisation of the ASS, Deutsche Motor Sport Wirtschaftsdienst GmbH, their presidents, bodies, managing directors, general secretaries,
 - the ADAC districts, the promoter/series organiser, the organiser, the marshals, the race track owners,
 - authorities, racing services and all other persons associated with the organisation of the event,
 - the road construction authority, insofar as damage caused by the nature of the roads to be used at the event, including accessories,
- are caused,
- the vicarious agents and vicarious agents of all the aforementioned persons and races,
 - the TR-Register Deutschland e.V., its board, its members, the British HTGT Competition Officer
 - companies, their directors, their employees,

except for damages resulting from injury to life, limb or health that are based on an intentional or negligent breach of duty – including by a legal representative or a vicarious agent of the released group of persons, and except for other damages that are based on an intentional or grossly negligent breach of duty – including by a legal representative or a vicarious agent of the released group of persons, against:

- the other participants (applicants, drivers, passengers), their helpers, the owners, owners of the other vehicles
- your own applicant, your own driver(s), passengers (special agreements between applicant, driver, passenger to the contrary!) and your own helpers

You waive claims of any kind for damages arising in connection with the racing competition (untimed, timed training, warm-up, race), slalom in connection with training and scoring run(s), except for damages resulting from injury to life, limb or health, which are based on an intentional or negligent breach of duty – including by a legal representative or vicarious agent of the released group of persons, and except for other damages that are based on an intentional or grossly negligent breach of duty – including by a legal representative or a vicarious agent of the exempted group of persons.

The disclaimer agreement becomes effective vis-à-vis all parties involved upon submission of the name.

The waiver of liability applies to claims based on any legal grounds, including but not limited to claims for damages arising from contractual and non-contractual liability, as well as to claims arising from tort. Implied disclaimers remain unaffected by the above liability clause. The participant agrees to the publication of photos and names as part of the series.

Power of attorney to submit entries for the ranked races:

Applicants/drivers authorize the TR-Register Deutschland e.V. to enter in my/our name for the individual events at which ranked races for the Int. British HTGT Competition are carried out and to accept entry confirmations with effect for and against applicants/drivers. The coordinator of the British HTGT Competition is entitled to grant sub-authorisation. The right of the organizer to refuse entries remains unaffected.

I'm competing in all racing events as a registered driver for the 2025 British HTGT Competition Championship.

I will take part in races of the British HTGT Competition 2025 as a guest starter.
